### TENDER NOTICE – PARIVARTAN SHALA

Sealed tenders are invited from experienced and reputed vendors for the implementation of Parivartan Shala – Smart Primary School in Gundala Block, Bhadradi Kothagudem District, Telangana.

#### 1. Scope of Work

1.1 Name of Work -Implementation of Parivartan Shala – Smart High School Infrastructure & Digital Learning Interventions for 10 Primary Schools, including supply, installation, painting, electrical and civil works as per AFPRO specifications.

1.2 The work shall be executed strictly as per the technical specifications mentioned in Annexure – I & Annexure – II of this tender document.

#### 2. Availability of tender documents

#### 3. Rate to be Quoted

3.1 The bidders shall quote their rates both in figures and words in the “Price Bid” format (Annexure – I) and the quoted rate shall be inclusive of all applicable taxes and duties.

3.2 Evaluation shall be based on the lowest quoted workable rate and AFPRO reserves the right to reject unworkable or unrealistic bids.

3.3 Overwriting, corrections without authentication, or discrepancy between figures and words may lead to rejection, and Rates quoted in words shall prevail in case of mismatch.

3.4 In case the quoted rates are abnormally lower than the anticipated estimates, AFPRO reserves the right to call justification from bidder. Further the bidder may have to submit a performance guarantee in form of bank guarantee towards the differential amount.

#### **4. Submission of tender**

4.1 Tenders shall be submitted by post or in person only.

4.3 Last date of submission: 08<sup>th</sup> January, 2026 up to 5:00 PM.

4.4 Tenders received after the deadline will not be accepted. It is the responsibility of the bidder to ensure and confirm that the tender is received in time by AFPRO.

4.5 Queries pertaining to tender, if any, may be clarified by contacting AFPRO Regional Office, Phone:9754451677 during office hours (9:00 AM -5:00 PM) from Monday to Friday.

4.6 Interested bidders can visit the site at their own cost and familiarize themselves with the site conditions, concerned areas and to go through the terms and conditions of the tender document before submission.

4.7 Tenders not received in prescribed form will be liable to be summarily rejected.

4.8 Tenders not adhering to the terms and conditions are liable to be rejected.

4.9 AFPRO reserves the right to accept or reject any or all tenders without assigning any reason thereof.

4.10 The tender documents have to be signed by the bidder on each page and the terms and conditions must not be altered, failing which the tender will be rejected.

4.11 Tender form containing "overwritten" or "erased" rate or rates and amount not showing figures and words in English will be liable to rejection.

4.12 Tender containing clerical or arithmetical mistakes may be rejected.

4.11 Any request from the bidder in respect of additions, alterations, modifications etc. of either terms or conditions or rates of his tender after opening of the tender may lead to rejection of tender.

#### **5. Tender opening**

5.1 Techno-commercial bids shall be opened in the presence of the designated committee of AFPRO. Price bids of bidders whose techno-commercial bids are found acceptable will be opened on 09<sup>th</sup> January, 2026 at 12:00PM in the presence of the designated committee. Interested bidders may be present during opening.

5.2. AFPRO reserves the right not to accept the lowest offer. AFPRO also reserves the right to cancel the tender. No claims of any bidder in this regard shall be entertained.

5.3. The validity of the offer shall be 30 days from the date of submission of the tender

## **6. Date of commencement of work**

6.1 The successful bidder should commence the work immediately after issuing of the work order/agreement.

**7. Jurisdiction-** The jurisdiction shall be New Delhi, Delhi

## **8. Eligibility Criteria**

8.1 The bidder must: Be a registered firm/contractor & Have completed minimum three similar works in the last five years

8.2 Have experience in school infrastructure, digital learning, civil & electrical works

## **9. Area of Work**

9.1 The project area is located in Bhadradri Kothagudem District, Telangana. & AFPRO shall provide exact locations of schools.

## **10. Award of the contract**

10.1 After evaluation of the received offers through bid process, the contract may be awarded to the lowest bidder.

10.2 Notwithstanding the above, AFPRO Reserves the right not to award the contract to the lowest bidder and may cancel or reject any part or whole of the tender without assigning any reasons whatsoever. The bidders shall not be entitled to any claims on account of the incidental expenses incurred.

10.3 Acceptance of the bid shall be intimated through letter of intent / work order. In turn, the bidder has to counter sign and return the same as token of acceptance.

10.4 An agreement may be entered between AFPRO and the selected Vendor for execution of work.

## **11. Work Schedule & Measurement**

11.1 The Vendor shall submit a detailed work schedule in consultation with AFPRO Team & engineer.

11.2 All works shall be measured and recorded in the Measurement Book (MB) maintained by AFPRO.

## **12. Terms & Conditions**

### **A.1. Acknowledgement**

Upon receipt of the Request for Quotation (RFQ) please inform AFPRO if you intend to submit a quotation. Please respond even if you are not interested to submit a quote (in writing)

## **A.2. Price**

The price quoted by the Vendor/Service Provider shall not be subject to adjustments on any account except as otherwise provided in the conditions of the Purchase Order/Work Order/TOR. Price should be quoted in INR.

## **A.3. Validity & Closing date**

Quotation must be received by AFPRO as specified on page 1 & 2 not later than the closing date and time. Quotations received after the closing date and time will not be considered.

## **A.4. Award of Purchase Order/Work Order/ TOR and Criteria**

AFPRO will award the Purchase Order/Work Order/ TOR to the Vendor/Service Provider/Contractor whose quotation has been determined to be substantially responsive to this Request for Quotation (RFQ) and who has offered the lowest evaluated price/fees/amount, provided further that the Vendor/Service Provider/Contractor has the capability to supply/ carry out the work/service effectively as per Purchase Order/Work Order/TOR. AFPRO has its discretion to award the PO/Work Order/TOR to any party including the Vendor/Service Provider/Contractor who have submitted the quotation or otherwise.

AFPRO reserves the right to accept all or part of your quotation or reject, whichever is in its best interest.

## **A.5. Signature of Purchase Order/Work Order /TOR**

AFPRO will notify the successful consultant/Vendor/Contractor in writing with a Purchase Order/Work Order /TOR.

Within 2 days of receipt of the Purchase Order/Work Order /TOR from AFPRO, the Consultant/Vendor/Contractor must sign/accept Purchase Order/Work Order/TOR with date and seal and return it to AFPRO.

If the consultant/Vendor/Contractor fails to sign/accept and return the Purchase Order/Work Order/TOR and within 2 days after receipt of the Purchase Order/Work Order/TOR, AFPRO may consider the Purchase Order/Work Order/TOR stands cancelled without prejudice to the AFPRO's right to claim compensation or pursue any other remedy in respect of such failure, and the consultant will have no claim whatsoever on the AFPRO.

## **A.6. Cancellation for convenience**

AFPRO may for its own convenience and without charge or liability cancel the RFQ at any stage.

## **A.7. Other terms and conditions**

- All duties, taxes and transportation charges or any additional cost payable shall be shown separately in the quotation.
- The rates quoted by you for each item shall be fixed for the validity period of the quotation and shall not be subject to adjustment on any account.

- Quotation for supply of partial quantity of an item will not be acceptable.
- Payment shall be made in installments or fully as agreed in the Purchase Order/Work Order/ TOR through respective banks. You should indicate the Account Name, Bank Name, Account number, Bank Address & IFS Code on the quotation.
- Vendor/service provider should not influence or offer any monetary or non-monetary benefits to AFPRO staff to avail the procurement. If such instances have been noticed AFPRO has full right to cancel the Purchase Order/Work Order and claim the amount already paid from AFPRO to the Vendor/Service Provider with penalty.
